



# MOREY'S Piers AND WATER PARKS Official Guide

Observe each attraction before participating. Each attraction has specific rules for specific safety reasons. Failure to follow these rules is dangerous and may result in serious injuries to yourself or others. Read and obey all attraction signs, audio instructions, and verbal instructions. If you do not understand the instructions, ask a lifeguard or ride attendant.

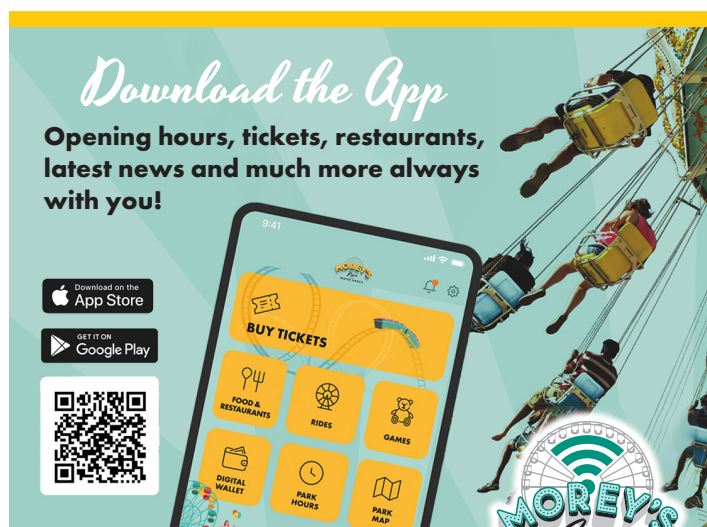
**WARNING:** Every Guest has different capabilities and limitations, and every attraction has associated risks. As such, certain individuals are at increased risk for injury from these attractions. Only you know your physical condition and limitations. Please carefully evaluate each attraction to determine if you, or members of your party, can safely participate. **DO NOT RIDE** if you could aggravate a pre-existing condition or you believe your health could be at risk for any reason.

## We Care about your Kids...

- Please observe the attraction before participating. Read all rider requirements to your child and speak with them about how to ride and slide safely.
- Tell your child to:
  - Listen to all instructions.
  - Hold on with both hands.
  - Remain seated until the ride stops completely and they are told to exit.
  - Never run.
- NEVER force your child to ride if they are afraid.
- Do not reach into ride areas to touch or "Hi-Five" your child once they are seated.
- Non-swimmers and weak swimmers should wear a lifejacket while participating in the water and on water park attractions.

## AMUSEMENT RIDES SAFETY

- ✓ Loose articles, including cell phones, purses, stuffed animals, cameras, selfie sticks, etc. are not permitted on most rides. Please leave loose articles with a non-rider, use the provided loose article storage available at some rides, or store them in a locker prior to joining the line. Morey's Piers and its Associates are not responsible for articles that are lost, stolen, or damaged while riding or when left in any storage area.
- ✓ Keep all parts of your body inside the ride at all times.
- ✓ Secure all loose articles, clothing, and long hair.
- ✓ Remain seated in an upright position.
- ✓ Hold on until the ride comes to a complete stop and you are instructed to exit.
- ✓ Keep all restraints fastened until the Operator instructs you to exit.
- ✓ Shoes are required on most rides. Certain rides have shoe-type restrictions. Restricted shoe types may include flip-flops or similar shoes.
- ✓ Food, drink, and smoking are not permitted on any ride.
- ✓ Throwing objects and horseplay are not permitted.
- ✓ NEVER enter a ride area without the Operator being present and consenting.
- ✓ While rare, evacuations may be required due to mechanical issues, weather conditions, or power interruption. Evacuating may require you to step over and around objects and walk down steep inclines.

## WATER PARKS SAFETY

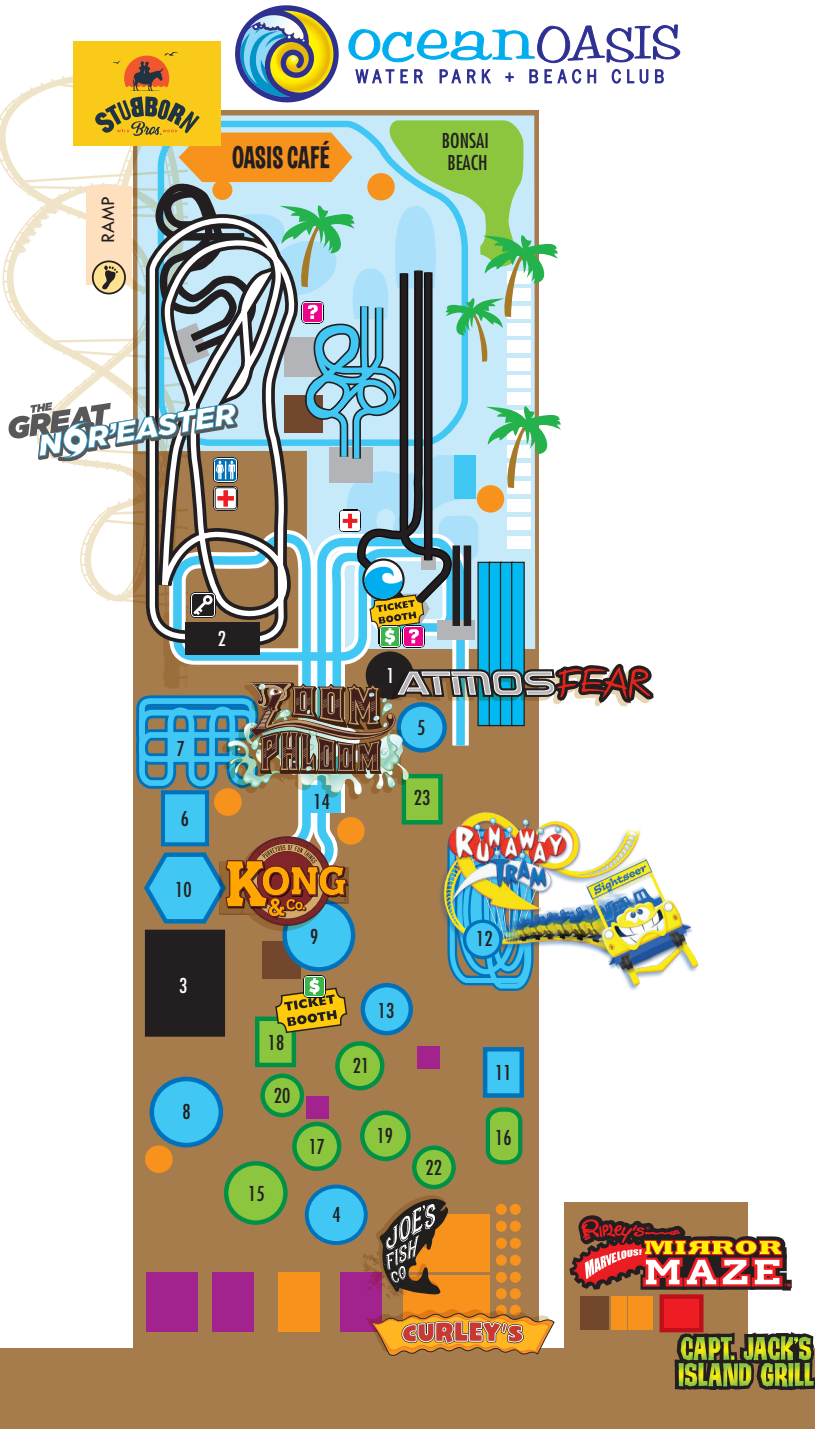
- ✓ If you or anyone in your group is unsure of their ability to swim, do not swim without a life jacket. Life jackets are available free of charge at both water parks. Please see any staff member for assistance.
- ✓ No diving or horseplay.
- ✓ On double tube rides, be aware of your riding partner's position and maintain a safe distance.
- ✓ No glass containers of any type are permitted in the parks.
- ✓ Children under 3 years of age must wear an approved swim diaper.
- ✓ The entire premises of our water parks will, at times, be covered in water.
- ✓ Do not run.
- ✓ All shoes, including water shoes, are not permitted on any slide.
- ✓ Do not engage in breath holding games while swimming.
- ✓ Do not enter the water if you are experiencing or recovering from diarrhea or have had any signs or symptoms of a stomach disease in the past seven days.
- ✓ As a part of our safety program, our associates participate in practice drills during operational hours. These drills may involve rescue equipment, manikins, and live participants.

## OTHER TERMS, CONDITIONS, AND LIMITATIONS

- For the safety of all our Guests and Associates, selfie sticks are not permitted to be used at any time while on Morey's Piers property and are not permitted to be brought on or into any ride or attraction.
- We reserve the right to inspect all persons and articles which enter any Morey's Piers property.
- Morey's Piers and its Associates are not responsible for lost or stolen items. Most rides do not permit loose articles. Please leave all loose articles with a non-rider.
- For everyone's safety, you are responsible for following all verbal and written instructions and ensuring younger guests in your party do the same.
- Cell phones are not permitted to be used on any roller coaster or dynamic thrill ride.
- Any Guest who may jeopardize their own or another's safety, will not obey the rules and regulations of an attraction, or are giving the indication of being under the influence of alcohol or drugs will be required to leave the premises and may face criminal prosecution under NJSA 5:3-36.1.
- The Purchase and use of any ticket is subject to all rules, terms, and conditions found at [www.moreyspiers.com/terms-conditions](http://www.moreyspiers.com/terms-conditions). All guests are subject to attraction-specific requirements and restrictions. Guests who do not comply with park rules will be required to leave. All accidents or injuries must be reported in accordance with posted instructions. First Aid stations are located on all piers and inside all water parks. All claims, including but not limited to claims arising from participation in rides or games, shall be brought exclusively in the Courts of the State of New Jersey located in Cape May County.
- Approaching severe weather may cause some or all attractions to close temporarily. All rides and attractions will reopen as soon as we determine it is safe to do so.



## SURFSIDE PIER AT 25TH AVENUE



### RIDE RATING SYSTEM

All ride ticket signs are designed to look like one of the following shapes. Please use this system as a guide in determining which attraction to ride based on your experience level, physical condition and abilities.

- ◆ **HIGH THRILL RIDES** - High speeds with extremely unusual and stressful physical forces. This ride contains startling and unexpected thrills appropriate for only the most healthy and physically able riders.
- **MODERATE THRILL RIDES** - Moderate speeds with unexpected movements and stressful physical forces. This ride may contain unanticipated thrills.
- **MILD THRILL RIDES** - Low speeds with expected movements and anticipated thrills.

#### ◆ HIGH THRILL RIDES (#) OF TICKETS REQUIRED

1	ATMOSFEAR* (9)	48" tall to ride.
2	THE GREAT NOR'EASTER* (10)	52" tall to ride, maximum height of 79".
3	"IT"* (9)	56" tall to ride, maximum height of 79".

#### ■ MODERATE THRILL RIDES

4	BALLOON RACE (5)	48" tall or accompanied by a supervising companion. One supervising companion may accompany no more than two children. Infants ride free!
5	CYGNUS X-1 (6)	48" tall to ride.
6	DANTE'S DUNGEON* (5)	42" tall or accompanied by a supervising companion.
7	DOO WOPPER* (8)	48" tall to ride alone. 36-48" tall must be accompanied by a supervising companion. Under 36" not permitted.
8	KANG'A BOUNCE* (5)	48" tall to ride alone. 42-48" tall must be accompanied by a supervising companion. Under 42" not permitted.
9	KONG* (5)	44" tall to ride alone. 36-44" tall must be accompanied by a supervising companion. Under 36" not permitted.
10	ROCK AND ROLL (6)	48" tall to ride.
11	ROCKIN' TUG* (4)	42" tall or accompanied by a supervising companion.
12	RUNAWAY TRAM* (8)	48" tall to ride alone. 40-48" tall must be accompanied by a supervising companion. Under 40" not permitted.
13	TILT-A-WHIRL (5)	46" tall or accompanied by an adult. Under 6 years, who meet the height requirement, must be accompanied by an adult.
14	ZOOM PHLOOM* (8)	48" tall or accompanied by a supervising companion. Under 42" not permitted. One supervising companion may accompany no more than two children. No single riders.

#### ● MILD THRILL RIDES

15	CAROUSEL* (4)	40" tall or accompanied by a supervising companion. Under 5 years, who meet the height requirement, must be accompanied by a supervising companion. Supervising companion must stand next to horse on which the child is riding. If riding in a spinning tub, hair longer than waist length must be secured.
16	CONVOY** (3)	36" tall or accompanied by a supervising companion.
17	CYCLE JUMP (3)	36" tall to ride, maximum height of 60".
18	HAPPY FEET* (3)	36" tall to ride alone. 31"-36" tall must be accompanied by a supervising companion. Under 31" not permitted. Maximum height of 73".
19	HOWITZER* (3)	Child must exhibit independent posture control.
20	JUMP AROUND** (3)	36" tall or accompanied by a supervising companion.
21	KIDDIE BOATS* (3)	Child must exhibit independent posture control. Maximum height of 52".
22	MAGIC BIKES* (4)	48" tall to ride alone. 42-48" tall must be accompanied by a supervising companion. Under 42" not permitted.
23	WACKY WHIP** (4)	36" tall or accompanied by a supervising companion.

- ◆ Cliff Dive, Sidewinders, Shotgun Falls, Riptide Rapids
- Activity Pool, Rocket Raft Run, Endless River WipeOut! (42" height requirement.)

## MARINER'S PIER AT SCHELLENGER AVENUE



### ◆ HIGH THRILL RIDES (#) OF TICKETS REQUIRED

- 1 **GHOST SHIP\*** (10) *Not recommended for children under 10 years of age.*
- 2 **SEA SERPENT\*** (10) *48" tall to ride.*

### ■ MODERATE THRILL RIDES

- 3 **BALLOON RACE** (5) *42" tall or accompanied by a supervising companion. One supervising companion may accompany no more than two children. Infants ride free!*
- 4 **CRAZY BUS\*\*** (4) *36" tall or accompanied by a supervising companion.*
- 5 **FLYING GALLEONS** (5) *48" tall or accompanied by a supervising companion. Under 10 years, who meet height requirement, must be accompanied by a supervising companion. One supervising companion may accompany no more than 2 children. Infants ride free! No single riders.*
- 6 **GIANT WHEEL\*** (6) *56" tall or accompanied by an adult. Under 10 years, who meet the height requirement, must be accompanied by an adult. One adult may accompany no more than two children. Infants ride free! No single riders. Persons with developmental disabilities must be accompanied by an adult.*
- 7 **KITE FLYER\*** (5) *42" tall to ride.*
- 8 **MOBY DICK\*** (6) *48" tall to ride alone. 42-48" tall must be accompanied by an adult. Under 42" not permitted.*
- 9 **MUSIK EXPRESS** (6) *55" tall to ride alone. 48-55" tall must be accompanied by an adult. Under 48" not permitted.*
- 10 **PIRATES OF THE WILDWOODS\*** (5) *48" tall or accompanied by a supervising companion. No single riders.*
- 11 **RIPTIDE\*** (6) *48" tall to ride alone. 40-48" tall must be accompanied by an adult. Under 40" not permitted.*
- 12 **ROLLIE'S COASTER\*** (8) *50" tall to ride alone. 44-50" tall must be accompanied by an adult. Under 44" not permitted. Maximum height of 75".*
- 13 **SUNNY'S LOOKOUT LIGHTHOUSE\*** (5) *48" tall to ride alone. 42-48" tall must be accompanied by a supervising companion. Under 42" not permitted. Maximum height of 80".*
- 14 **SUPER SCOOTERS\*** (5) *52" tall to ride alone. 48-52" tall must be accompanied by an adult. Under 48" not permitted. Must be over 52" tall to drive.*
- 15 **TEA CUPS\*** (5) *50" tall or accompanied by an adult. Hair longer than waist length must be secured.*
- 16 **WALTZER\*** (5) *46" tall or accompanied by a supervising companion. Under 6 years, who meet the height requirement, must be accompanied by a supervising companion.*
- 17 **WAVE SWINGER\*** (6) *48" tall to ride.*
- 18 **WILD WHIZZER\*** (6) *48" tall to ride alone. 36-48" tall must be accompanied by a supervising companion. Under 36" not permitted.*

### ● MILD THRILL RIDES

- 19 **AIRPLANES\*\*** (3) *36" tall or accompanied by a supervising companion.*
- 20 **BABY VENICE\*** (3) *Child must exhibit independent posture control. Maximum height of 52".*
- 21 **CAROUSEL\*** (4) *40" tall or accompanied by a supervising companion. Under 5 years, who meet the height requirement, must be accompanied by a supervising companion. Supervising companion must stand next to horse on which the child is riding. If riding in a spinning tub, hair longer than waist length must be secured.*
- 22 **HENEKEE** (3) *Child must exhibit independent posture control. Maximum height of 56".*
- 23 **KIDDIE SWINGS\*** (3) *36" tall to ride. Children whose feet can touch the ground once seated, or exceed 54" in height, are not permitted to ride.*
- 24 **MINI SCOOTERS\*** (4) *36" tall to ride, maximum height of 52".*
- 25 **PINK ELEPHANTS\*** (3) *36" tall or accompanied by a supervising companion.*
- 26 **SEAGULL CYCLES** (5) *48" tall or accompanied by a supervising companion. Under 10 years, who meet the height requirement, must be accompanied by a supervising companion. 48" maximum height for front seat passengers.*

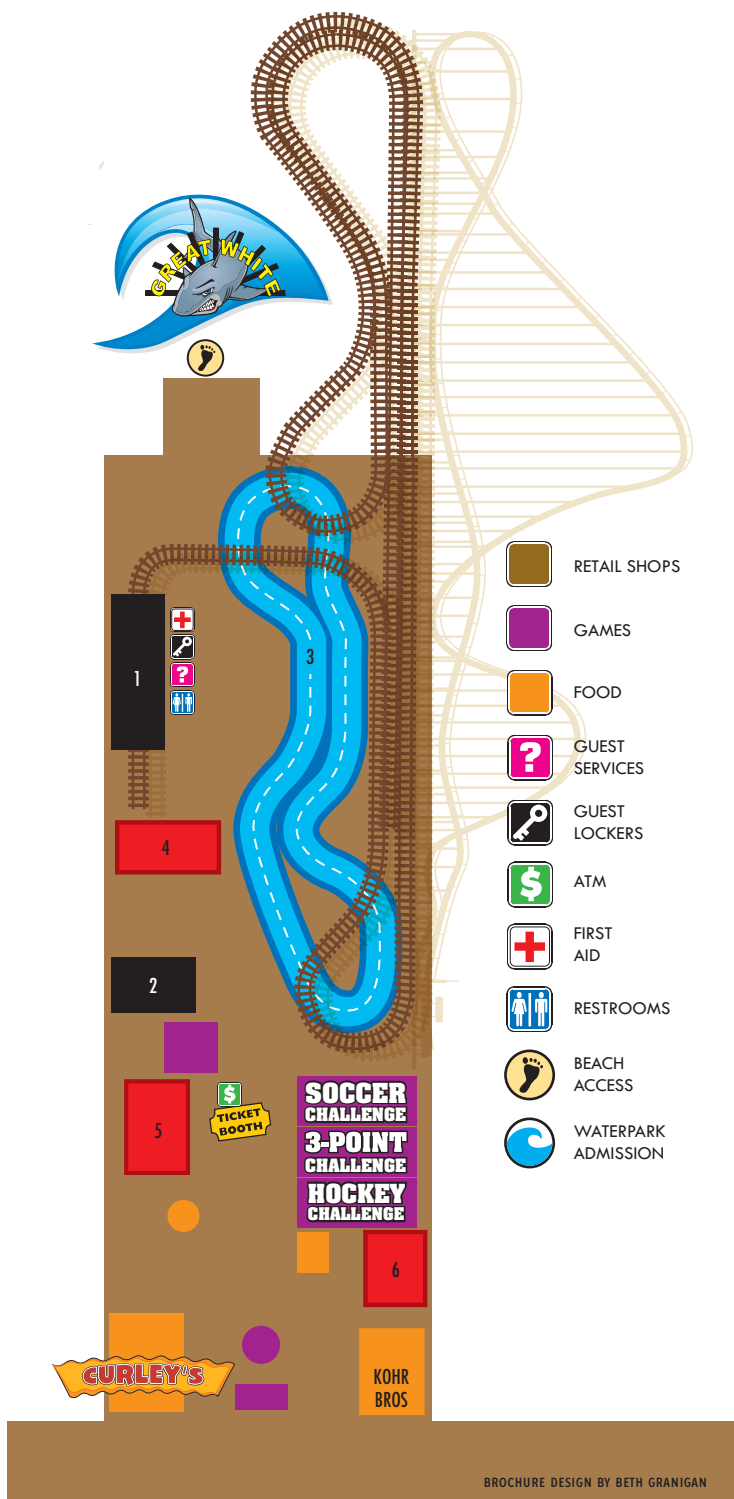

### ◆ HIGH THRILL RIDES (#) OF TICKETS REQUIRED

- 1 **GREAT WHITE\*** (10) 48" tall to ride.
- 2 **SCREAMIN' SWING** (8) 48" tall to ride.

### ADDED ATTRACTIONS NOT INCLUDED IN THE RIDE WRISTBAND.

- 3 **GRAND PRIX RACEWAY\*** (8) 56" tall to drive. Not recommended for children under 14 years of age. These are self controlled motor vehicles, please see attendant if you are a first-time rider. Hair longer than shoulder length must be secured. Guests must be able to utilize the gas and brake pedals and have full use of at least one hand to ride. Double Seat Vehicles: One child per adult. Passengers must be at least 44" tall. Driver must be at least 16 years of age.

### XTREME RIDES NOT INCLUDED IN THE RIDE WRISTBAND.

- 4 **SKYCOASTER** (22) 42" tall to ride. Must have upper body control, one leg, two arms, and complete use of at least one hand in order to ride. Guests with development disabilities must be accompanied by a guardian to monitor response of the Guest during winch-up and to limit the launch height if appropriate.
- 5 **SKYSCRAPER\*** (22) 52" tall to ride.
- 6 **SPRING SHOT** (30) 50" tall to ride. T-Shirt and video package deal available.



If your child does not meet the minimum requirements to ride alone and has a valid wristband or ticket card, you can accompany them on the following rides with a Parent's Limited Ride Pass. Ask for your pass at any of our ticketing windows.

Rides included in this program are:

SURFSIDE PIER: Carousel, Convoy, Howitzer, Jump Around, Wacky Whip

MARINER'S PIER: Airplanes, Carousel, Crazy Bus, Pink Elephants

## IMPORTANT INFORMATION:

### OTHER RESTRICTIONS POSTED AT EACH RIDE.

**\* RAMPED OR LEVEL ACCESS AVAILABLE.** Guests must transfer to the ride vehicle themselves or be assisted by a member of their party. Elevator access available on the DooVopper, Runaway Tram, Wave Swinger, Kong, Wild Whizzer, and Great White.

### \* PARENT'S LIMITED RIDE PASS

**INDEPENDENT POSTURE CONTROL:** Independent posture control is defined as having the ability to sit upright and hold on without assistance.

**SUPERVISING COMPANION:** A person who is 14 years of age or older, is able to understand rider instructions, is able to assist a guest (under the minimum height to ride alone) in complying with rider instructions, and who meets all other criteria for riding alone.

Rider requirements are set by management, ride manufacturer and state agencies and will be strictly enforced. Other requirements not included in this brochure are posted at each ride. All requirements will be strictly enforced and are subject to change.

Our attractions are designed by manufacturers to accommodate the "average" rider.

Very large framed or small individuals may not be safely accommodated by some rides.

**OFFICIAL HEIGHT MEASUREMENT:** Morey's Piers offers Official Height Measurement at any Pier Guest Services. If your child is on the borderline of any height requirement, please come to Guest Services upon your arrival and ask to be officially measured. An Associate will measure your child using a hospital quality Stadiometer and issue a wristband noting his or her exact height. Your child will still be measured at every ride, but if there is a question concerning height, the Operator will check the wristband and allow your child to ride if appropriate.

Opening times, closing times, ride availability, and operating hours are subject to change at anytime based on various factors including weather and crowd conditions.
